apply to MangoTreesDao. 1. Please know what information we collect from you. We collect the following information from you for the purpose of meeting
your service needs on MangoTreesDao, and we attach great importance to

the protection of your privacy. When we collect

your information, we will strictly abide by the principles of "lawful, legitimate and necessary". And you know that if you do not provide the relevant information required for our services, your service experience at MangoTreesDao may be affected. To the extent permitted by laws and regulations, we may collect and use your personal information in the following situations without obtaining your authorization and consent:

- (1) Relevant to national security and national defense security;
- (2) Relevant to public security, public health, and major public interests;
- $(3) \ Relevant \ to \ criminal \ investigation, \ prosecution, \ trial \ and \ judgment \ execution, \ etc.; \ (4) \ The$

personal information collected is disclosed to the public by you yourself; (5) Your personal

information is collected from legally publicly disclosed information, Such as legal news reports, government information disclosure and other channels

(6) Necessary to maintain the security and compliance of services, such as discovering and handling product and service failures;

You have the following independent control over your personal information in MangoTreesDao:

MangoTreesDao will show you the information to log in to your account.

You know that you can modify your name, avatar, email and other activities through the "Personal" section. You know that in the MangoTreesDao section, you can freely choose to perform the following operations:

- (1) In "Personal", personal information can be modified;
- (2) In "Blog", you can choose to view the published blog content and like and comment. (3) In the "Personal

Center", you do not need to provide your name, mobile phone number, bank card and other information.

You understand that when we collect information from you for a specific purpose, we will notify you in advance and you have the right to refuse. You know that you and we have no control over whether your transaction records are made public, because based on the open source nature of the blockchain trading system, your transaction records are open and transparent in the entire blockchain system.

- 1. We will store your personal information for business and legal purposes. 2. We will

not sell, trade or transfer your personal information to third parties without your consent.

- 3. If you agree to us disclosing your personal information to strategic partners or affiliates, we may disclose your personal information to such entities.

  These entities will only use your personal information for the purposes for which you have consented. 4. You agree that we may disclose or share your personal information with the following third parties:
- (1) Service providers and data processors who represent us and provide services to us, such as KYC checks, accounting, data processing or management services, website hosting, maintenance and operation services, email information services, analysis services, payment Transaction processing, marketing, etc.; and

If we need to transfer your personal information to any other country for the above purposes, we will obtain your consent and ensure that the recipient of the personal information has the same level of personal information protection measures as us. If such countries or regions do not yet have personal information protection laws that apply to our relationship with you, we will enter into a legally enforceable agreement with the recipient of the personal information. 6. We use automatic data collection technology in our applications. For example:

- (1) Cookies (or browser cookies). Cookies are small text files set by the operator of a website or app to recognize your browser or device. Cookies do not capture information that can identify you, but the information they collect can help us analyze the use of the application to improve your experience. You can turn off cookies in your browser settings. However, this may affect the functionality of the app.
- (2) Network analysis. Web analytics is a method of collecting and evaluating the behavior of visitors to web pages and mobile applications. This includes analyzing traffic patterns, for example to determine how often certain features of a website or mobile app are accessed, or to understand what information or services are of most interest to visitors. Our application uses web analysis services provided by third-party tools. 6. How we protect your information
- (1) If we cease operations, we will promptly stop collecting your personal information, announce the notice of cessation of operations, and delete or anonymize your personal information held within a reasonable period.
- (2) In order to protect your personal information, we will take data security technical measures, improve internal compliance levels, increase internal employee information security training, and set safe access permissions for relevant data to safely protect your private information.

the following special agreements to protect minors under the age of 18:
